That's what this group is about - lending support to those who need it, and increasing awareness about the gay community while educating the heterosexual community.



Don't make students pay for GLBA

Members of the gay community wonder: Why do those opposed to the gay agenda waste time denouncing the ostensibly private act of same-sex fornication? The discussion about the GLBA's application for

ASWSU committee status following Peter Himmel's caustic commentary seems hung on this point.

Well, here's the deal. If gay activists weren't applying for the right to use our money to advance their agenda, y'all wouldn't hear much from us.

While the language of Mr. Himmel's column distracted some from his point, it drew some illuminating responses. One reader wrote, "...behavior like Himmel's public display of meanness should not be tolerated by this campus community." What irony, that this remark should come from among the group making the most vehement demands for tolerance of marginal views and practices.

Another reader likened the denial of a committee-status budget to a denial of First Amendment rights, presumably to the freedom of speech. What line of reasoning leads people to conclude that refusing to finance public speech and actually using government force to smother speech are the same?

Supporters of the GLBA paint a cozy picture of a group dedicated to peer support, valiantly saving traumatized homosexuals from suicidal feelings induced by a malevolent society. A haven for the downtrodden gay man. A welcoming circle of friends for the outcast lesbian.

And who knows, maybe a buffet for the searching bisexual?

In reality, the GLBA may serve its members by providing a benign social setting and symathetic counseling. But the role of the GLBA has a much wider girth — it also functions as a springboard for unopposed political activism. That's why many are enraged by the notion of granting the GLBA committee status and a budget procured from student fees.

People who believe homosexuality is immoral or who are otherwise opposed to the gay agenda have heard enough pro-gay proselytizing from officials who draw their salaries from government funds. Enough is enough.

No doubt GLBA members will point to the likes of Peter Himmel and say, "We obviously need to double our current efforts, 'cause people just aren't educated yet."

Education. Gay activists use the word the same way Hitler used it: as a synonym for indoctrination. This is the most insidious kind of political propaganda - attempts to change the political climate concealed under the guise of education for the betterment of society.

The gay agenda demands more than tolerance of homosexuality, it requires that we show "acceptance, support, admiration, appreciation, nurturance." These words come from a column in the March edition of "Breaking the Silence," a publication of the Gay, Lesbian, Bisexual Program, distributed around

"There are those who would like for us to believe that tolerance is enough," the author, a prominent WSU Center for Human Rights employee, writes. "But I want to argue here that tolerance is not enough."

The column describes the phases of "understanding" reflected by each word in the list. This description delineates the ideological and political goals advanced by the GLBA and the GLBA Program.

The author concludes with an alarming line: "Don't make it too easy for someone who wants to keep us back to find a resource to quote." Irony aside, this line illustrates the subversive nature of the GLBA's political activity.

They understand how to use secrecy to obtain resources. Sen. John Musella's procedural tactic is the only reason most students know that the ASWSU Senate voted - and might vote again tonight — to fund the GLBA with student fees.

This evening, the Senate will reconsider granting committee status to the GLBA. Senators need not explore the reasons why we should not fund advocacy for a group distinguished only by its behavior. Nor must they decide whether homosexuality is immoral.

Tonight, the only principle senators must acknowledge is this: It is unconscionable to force constituents to finance the advancement of a political agenda they oppose.

A vote to make the GLBA a committee would be a grave violation of the student-electorate's trust. Worse, it would also violate the principles on which we base our concept of democracy. In America, we don't coerce people into aligning themselves, financially or otherwise, with any particular political posi-

Here's hoping our senators understand this principle and have the guts to uphold it.
