A lifestyle, gay or not, is not something that can be easily affirmed by the wearing of a particular garb. A lifestyle is more intrinsic than that and can only be affirmed by pratice and true commitment to the cause.

Gay persons have historically been discriminated against because their sexual practices do not conform to what is generally regarded as "natural" or "moral". In our "liberal" and "enlightened" time, they are still discriminated against.

In Oklahoma, a bill was passed last Thursday by that state's legislature that would allow school boards to fire teachers who engage in public homosexual conduct.

In a similar incident, the Washington State Supreme Court last year affirmed the firing of a Tacoma teacher because he admitted, when asked by school officials, he was gay. It was thus determined that he would be a bad influence on the children he was teaching. There was no other reason given for firing. Being gay was enough in the eyes of the school board.

More recently, a Seattle police officer has launched a petition drive to repeal city ordinances which prohibit discrimination on grounds of sexual preference in housing and hiring. The Seattle gay community is fighting the measure.

Across the country there are similar instances of gays and anti-gays battling over the gays' right to keep their lifestyle without governmental and community encroachments.

The battle will most likely continue.

Perhaps the best way to effect a change is for non-gays to become informed about the gays. They are living, breathing human beings, just like everyone else. They have feelings. More importantly, they should have the right to do what they want with their private lives.

The success of an effort by ASWSU to arrange for President Jimmy Carter to hold a "town hall" meeting in Pullman, rests with student enthu-


Without a consensus of backing by the student body for a presidential visit, Carter probably will not bother with WSU.
