Misinformation

In response to Ms. Liza Rognas' April 15 letter-to-the-editor on inaccurate information in Pro-Life letters to the editor, I would like to correct her misinformation. For example, for every one woman who is provided prenatal care at Planned Parenthood, more than 32 others receive abortions, according to the Planned Parenthood Federation of America 1989 Services Report

(PPFA). About 49% of women obtaining abortions have said in past surveys that they used no method to prevent pregnancy during the month they became pregnant (Henshaw, Silverman, "The Characteristics and Prior Contraceptive Use of U.S. Abortion Patients," Family Planning Perspectives, vol. 20). Since the 1973 Roe v. Wade Supreme Court decision, abortion on demand through all nine months of pregnancy is indeed legal in the U.S., and for no other reason than that a child be of the wrong sex (what would my friends in Feminists for Life think of that?); or the child have birth "defects" (what might Disabled People for Life think?); or that the child was conceived in the less than 1% of pregnancies that result each year from rape and incest combined: Julie Makimma and her mother (who was raped) might like to inform you about this-- they together formed Fortress International, an organization defending both victims of sexual assault pregnancy.

As far as learning about women's lives, and about Planned Parenthood's being "dedicated to bettering the lives of women and men in our communities," you should perhaps listen to the experiences of members of American Victims of Abortion, made up of the fathers, grandparents, sisters, brothers, and especially mothers of aborted infants who learned in the cruelest way just what abortion is really about (and now must live with such "betterment" as PAS-- Post-Abortion Syndrome). And of course the ones best fit to tell us about "women's choices" are those more than 4,300 per day in the U.S. who experience abortion themselves. But we're "terminating" them. I join you then, Ms. Rognas, in encouraging everyone to "learn about women's lives," for there is far more to being "informed" than you might think. (Note: I do not wish to criticize Planned Parenthood's activities other than abortion).


