
You suggest, Ms. T., that the

2. Housing parking permits which are issued for Uni-

- 3. Permits <u>ARE</u> required <u>AT ALL TIMES</u> in all Student Resident (dormitory) lots, Service Zones, and Handicapped Spaces.
- 4. Permits <u>ARE NOT</u> required, on weekends and after 5 p.m. Monday through Friday, in Staff lots, Student Commuter lots, and Parking Structures.
- 5. The fine for not having a parking permit is \$15.00. If you purchase an <u>annual</u> permit within 24 hours after receiving a #4 violation ("No Parking Permit"), the fine will be cut in half to \$7.50.
