Differing lifestyles discussed

The recent issue of Gay Funding has created impassioned arguments by both Christians and Gays. The assembly has tried to objectively mediate between the two groups based on rational argument: This is their folly. The issue is characterized by proponents with an emotional stake in the outcome. Both Christians and Gays have a very real commitment to their opposing lifestyles.

Although the Christian needs to understand the social and psychological causes of homosexuality, he can not regard it as anything less than sin. The per-son who defines himself in relation to God will view reality through the perspective of his creator

Yet, he must not forget to view himself from that perspective. The same Bible that calls homosexuality sin says of the Christian, "If we say we have no sin in us, we are deceiving ourselves and refusing to admit the truth." (I John 1:8)

Perhaps much of the hostility toward Gays would be mitigated through an understanding that all sin separates one from God. Christian orthodoxy suggests that self-righteoisness, an unloving attitude toward Gays, results in the same spiritual death as homosexuality. Love and understanding are necessary, especially if one really accepts the fact that what separates Christians from non-Christians is an acknowledgement of sin rather than the sin itself. On the other hand, Gays have

couched the debate in the language of natural rights, a slippery idea at best. Denial of funding is not an issue of denying Gays the "right" to assembly, live their lifestyle openly, or even to proselytize. It is merely the denial to use funds supplied by those who are opposed to the Gay lifestyle in order to perpetuate any kind of homosexual

activity. Joan Baez has been ap-plauded for going to jail rather than pay taxes to support a war she did not believe in. Why, then, are those who refuse to support a lifestyle they do not believe in censured?

The issue of Gay lifestyle and homosexuality should not be simply ignored. Neither should it be reduced to polemical appeals for the greatest number of supporters. The viability of a Gay lifestyle cannot be decided by a disinterested body: It is an issue tied to basic commitments about the nature of man, society, and God.

These are important considerations that demand much thought and the free exchange of ideas; however ASWSU, an organization representing the entire student body, cannot decide the issue for us.

The suggestions you made in your letter, sir, prove to me that you need to see an optometrist. You have a severe case of tunnel vision! You suggest that Damani Obafemi work with the companies involved and "show them that it would be more profitable for them in the long run for Blacks to enjoy the same rights and privileges as whites in the country'

What rights and privileges do you mean? Many "rights" are denied to Blacks, not just by the company, but by the law of the apartheid government.

Look the word up Mr. Newly. And these companies, dear Gary, have such high profits because their costs are incredi-bly low. This is due to the "wages" of the Black Laborer.

The highest salary paid to a Black is 80 percent lower than the salary of a white worker holding the same job. The annual salary of the Black in South Africa is considerably lower than the poverty level set by the government of South Africa.
