## Straight alliance not legitimate

Students - especially those on the ASWSU Senate and Services and Activities Fees Committee - should keep close tabs on which organizations plan on applying for their funds.

Why? Because it looks like history could repeat itself again - that is unless students make sure their money is not determined on the basis of who can yell and scream the loudest.

Nearly two years ago, several male students, teed off by what they felt was an unfair S & A fees allocation process - supposedly allowing for the Association for Women Students (AWS) to receive unwarranted funds - quickly formed the Association for Men Students (AMS) to promote awareness of men's issues.

The AMS eventually received \$6,000 in S & A fees for its proposed programs during the 1983-84 school year, by claiming its group deserved student funds just like the AWS.

However, the AMS turned out to be nothing more than a fraud for students as the group's leaders never spent a student cent on the men's issues programs that they promised during the S & A Fees Committee's hearings. In the end, the \$6,000 was added to the committee's allocation pool for this school year.

Now that a rigorous debate about funding the Gay People's Alliance has risen to the top of the agendas of the local, pseudo student politicos, out of the woodwork has come AMS II - the Straight Alliance, promising to promote "acceptable behavior" and "natural sexual desires and interactions.'

The Straight Alliance, like the AMS did, has plans to apply for student funding - either via the ASWSU Senate or S & A Fees Committee.

But students should realize the Straight Alliance is nothing more than a group formed two weeks ago for the sole purpose of opposing funding of the Gay People's Alliance - and nothing more. It's just too obvious. They have no intention of propagating students with the "natural sexual desires and interactions" that the group's leader, Garrett Seick, says they do. These pseudo revolutionaries should call themselves what they are - the "Gay People's Alliance Hate Group."

The Straight Alliance will try to change the focus of the debate on student funding of the GPA. Instead of allowing students to ask whether the GPA should receive student funds for promoting awareness and understanding of issues relating to the gay community, the Straight Alliance unfortunately will try to turn the debate into what is more acceptable and desireable and claim the GPA wants to promote homosexuality on the CUB Mall.

If the Straight Alliance succeeds in distorting the issue in the eyes of the students, that would be a tragedy. The Straight Alliance should do students a favor right now and stop asking for student money for the group - they aren't a legitimate student group.
